## Visa Application Form

### **VERY IMPORTANT INFORMATION: please read and complete**

A Tourist Visa is required by all persons entering the United Arab Emirates with the **exception** of Andorra, Australia, Austria, Belgium, Brunei, Bulgaria, Canada, China, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Great Britain, Greece, Holland (Netherlands), Hong Kong, Hungary, Iceland, Ireland, Italy, Japan, Latvia, Liechtenstein, Lithuania, Luxembourg, Malaysia, Malta, Monaco, New Zealand, Norway, Paraguay, Poland, Portugal Romania, Russia, San Marino, Seychelles, Singapore, Slovakia, Slovenia, South Korea, Spain, Sweden, Switzerland, United States, Vatican City and Citizens of the GCC countries. **We strongly advise against travelling before a visa has been covered by Dubai Immigration for nationalities not mentioned above.**

**ALL DETAILS BELOW MUST BE COMPLETED IN FULL**, and returned with **CLEAR scanned copy** of the first three pages of your passport **on JPEG File, Photo size 40kb maximum (Dimensions of the photo should be: 4.3cm x 5.5cm) , Photo type JPEG, Colored (compulsory)**. Along with copies of flight ticket confirmation (arrival & departure). Immigration require, that passports are valid for at least 6 (six) months after arrival date. UAE immigration regulations require additional security checks to be conducted on certain nationalities. This may add an additional 4 working days to the processing time, also UAE immigration regulations may prohibit Israeli passport holders or those with an entry stamp into Israel from entering the country.

Please note we will be unable to process the Visa without a valid credit card number, full name as appears on the card, with expiration date and signature of the cardholder. Visa charges are paid in advance to Dubai Immigration and are non-refundable even if visas are rejected by local authorities. The charge per visa is **AED 300.00**. When visa application is submitted, a minimum of **10 working days** is required for processing prior to arrival for individual travellers. Please note that the Dubai Immigration is **closed on weekends, Friday and Saturday**.
